## **RE: ADMISSION INTO THE TECHNICIAN CERTIFICATE IN LAW (PARALEGAL STUDIES)**

Please refer to your application for admission into the Technician Certificate in Law (Paralegal Studies) for the Academic Year 2024/2025.

I am glad to inform you that after NACTVET verification of your application, you are hereby given an offer of admission into the aforesaid programme. This is a one academic year programme, commencing on **Monday, 21<sup>st</sup> October, 2024**.

For your guidance, please read carefully the following instructions:

### **1. Location**

The Law School's Technician Certificate in Law (Paralegal Studies) will be conducted at the Law School of Tanzania premises located at plot No. 2005/2/1 off Sam Nujoma Road/Mpakani Road.

### **2. Arrival at the School**

The orientation programme and registration will commence on Monday, 21<sup>st</sup> October, 2024. Students selected for this intake must report at the Law School of Tanzania from 9.00 a.m on that day. Selected applicants are required to register themselves and the deadline for registration is Tuesday 25<sup>th</sup> October, 2023. Students shall be responsible for their travelling and other expenses.

### 3. Registration

- You will be required to register yourself officially for the Technician Certificate in Law (Paralegal Studies) programme. Registration will take place at Administration Block, 1<sup>st</sup> Floor Room, Room No. 102. Further information will be given on arrival.
- For registration purposes, you must produce the following:
  - i. Copy of Certificate of Secondary Education;
  - ii. Copy of Advanced Certificate of Secondary Education or Basic Certificate in NTA Level 4;
  - iii. Copy of birth certificate or some other document (Passport and National Identity Card) indicating your nationality;
  - iv. Duly filled medical examination forms enclosed in the Joining Instructions;
  - v. Two recently taken passport size photographs;
  - vi. Proof of payment of programme fee, as indicated in this Admission Letter.

### 4. Accommodation

The Law School has no accommodation facilities. Students shall, therefore, be responsible for arranging their own accommodation.

### 5. Medical Services

Students are strongly advised to have health insurance to cover for their medical expenses during study duration.

### 6. Indirect Costs

Students shall bear all indirect costs related to his/her studies at the School including meals, books & stationary, transport etc

### 7. Medical Examinations

- Admission into the programme is conditional upon a satisfactory medical examination report being received by the School before or upon arrival of any new student. Students are therefore required to undergo medical examination by a registered medical practitioner. **Under no circumstances will the School accept medical examination report which is not made by a qualified medical practitioner.**
- You are therefore, required to present the enclosed Medical Examination form to a registered medical practitioner requesting for a medical examination.

### 8. Fees

The programme fee is Tsh 1,325,000/=.

### 9. Modalities for Payment of Fees

- Fees i.e., TZS. 1,325,000/= (payable in two equal instalments) must be remitted using a Control Number to be obtained at the accounts

office, Administration Block, 4<sup>th</sup> Floor, Room Number 402.

- **Cash payments shall not be accepted under any circumstances.**
- The School shall levy a 2% surcharge or 50,000/= whichever is higher on any amount of money other than fees paid into the School's account meant for subsistence or incidental uses of students. Such private payments should be made to students directly.

**10. Declaration Regarding Compliance with Regulations and By- Laws**

All students accepting admission into the Technician Certificate in Law (Paralegal Studies) programme shall be required to sign "The Student Declaration Form" which is a binding undertaking by the student concerned that he/she shall abide by the regulations and by-laws of the School.
