SECOND WINDOW FOR ADMISSION INTO THE PRACTICAL LEGAL TRAINING PROGRAMME IN THE JUNE 2025 IN-TAKE

Introduction:

The Law School of Tanzania is a public training institution established by Act No 5 of 2007 [Cap. 425] to provide practical legal training for law graduates who aspire to become legal practitioners.

The School has resolved to open a new application window for **three hundred (300) applicants** only. Qualified candidates wishing to pursue practical legal training programme in June 2025 are invited to apply.

Applicants who were offered admission previously but failed to enroll for the programme within the time given must re-apply.

Entry Requirements:

1.0 An applicant must meet the following minimum qualifications to be admitted into the programme:

(a) He/she must be a holder of a Bachelor of Laws Degree or a person who has become eligible for the conferment of the Bachelor of Laws Degree of an accredited higher learning institution in Tanzania Mainland; or,

(b) He/she must be a holder of a Bachelor of Laws Degree or a person who has become eligible for the conferment of the Bachelor of Laws Degree of a higher learning institution recognized by the Tanzania Commission for Universities (TCU) and whose content is approved by the Council of Legal Education for purposes of admission to the School; or,

(c) He/she must have equivalent qualifications approved by the Council of Legal Education obtained from any institution within or outside Tanzania.

2.0 In addition to the above criteria, an applicant shall be eligible for the programme if he/she has studied and passed all the prescribed core courses of the Bachelor of Laws Degree programme shown in Table 1 below:

2.1 All foreign university certificates must be verified by the Tanzania Commission for Universities.

2.2 All foreign secondary school certificates must have their equivalence from the National Examinations Council of Tanzania.

Applications will be processed after verification of the payment of a non-refundable application fee of T.Shs. 20,000.00.
- 2.0 The applicant should pay application fee using the **control number** generated by the system.
