1.0 ORDINARY DIPLOMA IN LAWS WITH PARALEGAL STUDIES (NTA 5 & 6)

a) Holder of Advanced Certificate of Secondary Education (ACSE) with at least one principal pass and one subsidiary and having at least four passes at Form Four results, excluding religious subjects.

OR

b) Holder of a Basic Technician Certificate in Laws with Paralegal Studies from the Law School of Tanzania or Basic Certificate in Laws (NTA Level 4), Police Science, Policing and Security Management, Correctional Science, Law Enforcement from any recognized institution.

OR

c) Any other equivalent qualifications recognized by the relevant authority.

Note: All Foreign Secondary School Certificates must have their equivalence from the National Examinations Council of Tanzania.
