## ONLINE APPLICATIONS FOR ADMISSION INTO THE PRACTICAL LEGAL TRAINING PROGRAMME IN THE JANUARY AND JULY 2026

#### **Introduction:**

The Law School of Tanzania is a public training institution established by the Law School of Tanzania Act, Cap. 425, R. E. 2023 to provide practical legal training for law graduates who aspire to become legal practitioners in Mainland Tanzania.

The School has resolved to open the application window for **January and July 2026** intakes. Qualified candidates wishing to pursue a practical legal training programme in January and July 2026 are invited to apply. Candidates who were offered admission previously but failed to register must also apply afresh.

#### **Entry Requirements:**

- 1.0 An applicant must meet the following minimum qualifications to be admitted into the programme:
- (a) He/she must be a holder of a Bachelor of Laws Degree or a person who has become eligible for the conferment of the Bachelor of Laws Degree of an accredited higher learning institution in Mainland Tanzania; or,
- (b) He/she must be a holder of a Bachelor of Laws Degree or a person who has become eligible for the conferment of the Bachelor of Laws Degree of a higher learning institution recognized by the Tanzania Commission for Universities (TCU) and whose content is approved by the Council of Legal Education for purposes of admission to the School; or,
- (c) He/she must have equivalent qualifications approved by the Council of Legal Education obtained from any institution within or outside Tanzania.
- 2.0 In addition to the above criteria, an applicant shall be eligible for the programme if he/she has studied and passed all the prescribed core courses of the Bachelor of Laws Degree programme shown in Table 1 below:

- 2.1 All bachelor of laws degree certificates awarded by foreign universities must be verified and recognized by the Tanzania Commission for Universities.
- 2.2 All secondary school certificates awarded outside Tanzania must be verified and confirmed to meet recognition standards through the official equivalence process administered by the National Examinations Council of Tanzania.

### **Application Process and Proof of Academic Qualifications:**

- 1.0 Application to join the programme shall be done online using the link <a href="https://saris.lst.ac.tz/Registration">https://saris.lst.ac.tz/Registration</a> or the main link in the Law School website (online application). Applications will be processed after verification of the payment of a non-refundable application fee of T.Shs. 20,000.00.
- 2.0 The applicant should pay the application fee using the **control number** generated by the system during the processing of the application.
