NOTE:

- (i) Candidates awaiting the release of supplementary examination results shall not be permitted to register for or sit another supplementary examination in the same component until such results have been officially released.
- (ii) All candidates intending to sit for supplementary examination(s) must register through LAWSARIS no later than **Friday, 26 June 2026 at 3:30 p.m.**
- (iii) Candidates sitting for a supplementary examination in a particular subject for the second time or any subsequent attempt shall be required to pay a fee of TZS 30,000/= per subject. Proof of payment must be attached to the Supplementary Examination Ticket upon submission.
- (iv) Supplementary Examination Tickets must be submitted to the Academic Office (Room No. 101, Administration Block) for verification and signature.
- (v) All candidates registered to sit for supplementary examination(s) are required to submit their Supplementary Examination Tickets to the Academic Office, Room No. 101, Administration Block, for signature at least one day before the examination date
- (vi) All candidates are reminded that they must present their Student ID and Supplementary Examination Ticket for every examination session. Failure to comply with this requirement will result in denial of entry to the examination room.
- (vii) Any issue relating to a lost Student ID must be resolved no later than one (1) day before the scheduled examination date. Requests submitted after this deadline may not be accommodated.
